**TERMS OF USE:** All Ethernet cabling runs must use CAT5 (or above). It is the customer's responsibility to follow local country regulations, including operation within legal frequency channels, output power, indoor cabling requirements, and Dynamic Frequency Selection (DFS) requirements.

## Installation Requirements

- Phillips screwdriver (for rack- or wall-mounting)
- Standard-sized, 19" wide rack with a minimum of 1U height available (for rack-mounting)
- For indoor applications, use Category 5 (or above) UTP cabling approved for indoor use.
- For outdoor applications, shielded Category 5 (or above) cabling should be used for all wired Ethernet connections and should be grounded through the AC ground of the power supply.

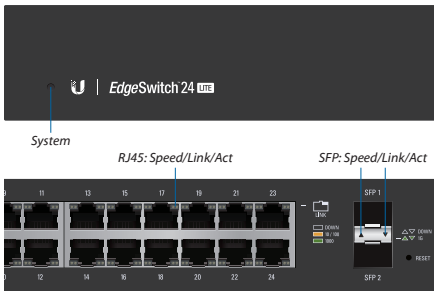

**Note:** Although the cabling can be located outdoors, the EdgeSwitch Lite itself should be housed inside a protective enclosure.

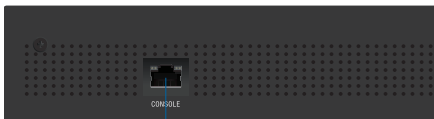

Reset	<p>There are two methods to reset the EdgeSwitch Lite to factory defaults:</p> <p><b>Runtime Reset (Recommended)</b></p> <p>The EdgeSwitch Lite should be running after bootup is complete, and the <i>System</i> LED is white. Press and hold the <b>Reset</b> button. The EdgeSwitch Lite will reboot, and the <i>System</i> LED becomes blue after three seconds. Continue to hold the <b>Reset</b> button for about 15 seconds until the <i>System</i> LED flashes blue for two seconds. This indicates that the EdgeSwitch Lite has reset to its factory defaults.</p> <p><b>Power-on Reset</b></p> <ol style="list-style-type: none"><li>1. Disconnect the <i>Power Cord</i> from the EdgeSwitch Lite.</li><li>2. While connecting the <i>Power Cord</i> to the EdgeSwitch Lite, hold the <b>Reset</b> button for about 15 seconds until the <i>System</i> LED flashes blue for two seconds. This indicates that the EdgeSwitch Lite has reset to its factory defaults.</li></ol>

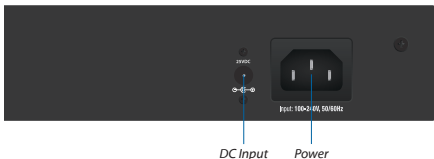

Then configure the following settings as needed:</p> <ul style="list-style-type: none"><li>• <i>Baud rate</i> 115200</li><li>• <i>Data bits</i> 8</li><li>• <i>Parity</i> NONE</li><li>• <i>Stop bits</i> 1</li><li>• <i>Flow control</i> NONE</li></ul>

## Back Panel Power

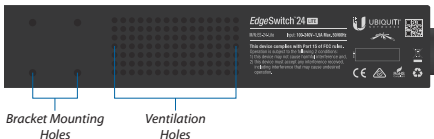


**DC Input** The 25VDC input can connect a redundant or stand-alone DC power source (not included) with minimum power: 25W, 25 to 16V, and 2.5 mm DC power inline connector.

**Note:** You can use the redundant DC power source as a hot spare; if the internal AC/DC power supply no longer provides power, then the EdgeSwitch Lite will switch to the DC power source without interrupting its operation.


**Power** Connect the included *Power Cord* to the *Power* port.

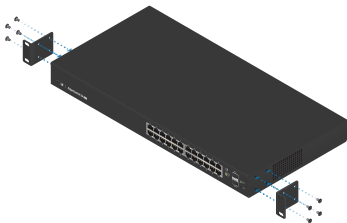
## Hardware Installation

The EdgeSwitch Lite can be placed on a horizontal surface, mounted on a wall, or mounted in a rack.

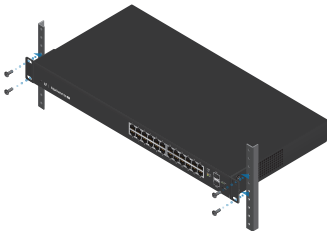
 **Note:** Keep 20 mm of clearance next to the ventilation holes for adequate airflow.

### Mounting in a Rack (Optional)

1. Attach the *Rack-Mount Brackets* to the EdgeSwitch Lite using the eight *Bracket Screws*.



2. Attach the EdgeSwitch Lite to the rack or wall using the four *Mounting Screws*. (If the rack has square slots, then use the *Cage Nuts* with the *Mounting Screws*.)



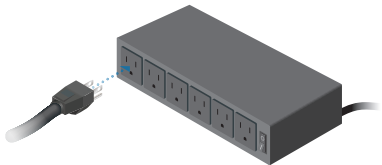


## Connecting Power

1. Connect the *Power Cord* to the *Power* port of the EdgeSwitch Lite.



2. Connect the other end of the *Power Cord* to a power outlet.

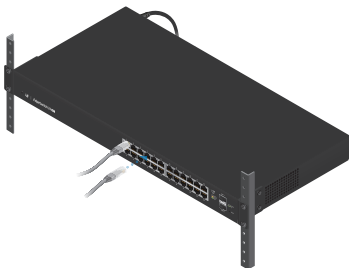


## Connecting Ethernet

1. Connect an Ethernet cable from your computer or host system to any port of the EdgeSwitch Lite.



2. Connect Ethernet cables from the Ethernet ports of your devices to the numbered ports of the EdgeSwitch Lite.



## Using SFP Ports

To use an *SFP* port:

1. Remove the protective plug covering the *SFP* port.
2. Plug a compatible fiber module into the *SFP* port.



3. Connect the fiber optic cable to the fiber module. Then connect the other end of the cable to another fiber device.

## Accessing the Configuration Interface

The EdgeSwitch Lite is set to *DHCP* by default, so it will try to automatically obtain an IP address. If that fails, then it will use the default fallback IP address, *192.168.1.2*. Proceed to the appropriate section, *DHCP* or *Fallback IP Address*:

### DHCP

Use one of the following methods:

- Set up the DHCP server to provide a specific IP address to the EdgeSwitch Lite based on its MAC address (on the label).
- Let the EdgeSwitch Lite obtain an IP address and then check the DHCP server to see which IP address was assigned.

To log in, follow these steps:

1. Launch your web browser. Type the appropriate IP address in the address field. Press **enter** (PC) or **return** (Mac).
2. The login screen will appear. Enter **ubnt** in the *Username* and *Password* fields. Read the Ubiquiti License Agreement, and check the box next to *I agree to the terms of this License Agreement* to accept it. Click **Login**.

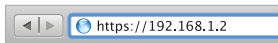

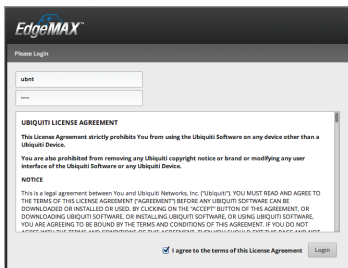

## Fallback IP Address

1. Ensure that your computer (or other host system) is connected to the EdgeSwitch Lite.
2. Configure the Ethernet adapter on your host system with a static IP address on the 192.168.1.x subnet.
3. Launch your web browser. Type the appropriate IP address in the address field (192.168.1.2 is the default fallback IP address). Press **enter** (PC) or **return** (Mac).



4. The login screen will appear. Enter **ubnt** in the *Username* and *Password* fields. Read the Ubiquiti License Agreement, and check the box next to *I agree to the terms of this License Agreement* to accept it. Click **Login**.



5. The EdgeSwitch Lite Configuration Interface will appear. Go to **System > Connectivity > IPv4**.
